The accounting year-end is 31 December.

Income is principally from voluntary donations in the form of regular giving as well as institutional funding (mainly Irish Aid).

# Requirements

- a) An external auditor experienced in auditing registered charities;
- b) Familiarity with FRS102/SORP accounting standards and best practice reporting in the Irish regulatory framework;
- c) Financial Year ended December 2024 audit to be conducted in February/March 2025 with the accounts completed for Board approval by end of April 2025;
- d) Fee quotation to take account of not-for-profit status of ActionAid Ireland (ActionAid Ireland cannot recover VAT costs)

e) ActionAid Ireland anticipates a three year contract with the option of a second three year contract

# Accountability and Management

The contract for services rests with ActionAid Ireland. Following completion of the tender evaluation, the successful tenderer will be notified in writing. Once the tender has been accepted, letters will be issued to the unsuccessful tenderer/s notifying them of the result.

# **Shortlisting and Clarification Meetings**

A shortlist of applicants may be invited to present or provide further information on their tender prior to selection. An invitation to interview will not be an indication that a contract has been awarded. Applicants attending such interviews will do so at their own cost. Meetings may be either held remotely or in person.

## Conflicts of Interest

Any conflicts of interest involving a tenderer must be fully disclosed in a timely manner to ActionAid Ireland. Failure to disclose a conflict-of-interest may disqualify a bidder or invalidate an award of contract, depending on when the conflict of-interest comes to light. If no conflict of interest exists, tenderers must indicate that in writing.

# Closing Date for Receipt of Tender

The closing date for receipt of the tender to ActionAid Ireland is **Tuesday 9<sup>th</sup> April 2024**.

Any tenders received after this time and date will not be considered.
